4. Please mention the make / brand & model or product quote of the item.
5. The valid technical offers will be evaluated by a Technical Assessment Committee (TAC) of the Institute.

The TAC will recommend the technically short-listed vendors for further consideration.

The offers of the technically shortlisted vendors / products will only be considered for price comparison.

6. The successful quotationer shall have to supply & install the equipment to this Institute at his own risk and responsibility and in good condition in all respects. After successful installation expertise from the supplier should give proper demonstration to the professional staff of the Institute for the use of the equipments.
7. The standard warranty conditions of the quoted products should be mentioned.

8. The quotation notice is to be duly signed on all the pages as a token of having accepted all the terms and conditions (no thumb impression is to be affixed).
9. **The quotation shall consist of 2 parts, namely Part-I (Technical) and Part-II (Commercial), in separate sealed covers. Part-I & Part-II offers shall be submitted in one sealed cover and this will be received upto 2:00 PM of 11.07.2018 and the same will be opened on the same day at 3:00 PM.**
10. The quotationer should submit their relevant credentials along with the Technical Offer (Part-I) of the Quotation as follows:
- (a) Particulars of the participating firm / vendor / company (quotationer)
  - (b) Certificate of previous experience of supply & installation of similar product with list of institutions (in case of supplier); OR,
  - (c) Certificate of dealership / distributor etc. from the appropriate manufacturer in case the quotationer is a dealer / distributor; OR,
  - (d) Certificate in regard to license of manufacturing in case of manufacturer.
  - (e) Certificate in regard to registration of firms along with trade license
  - (f) Detail technical specifications of the quoted products with make and model
  - (g) Bank Account details of the company / vendor
  - (h) GST Registration Number
  - (i) PAN Number
11. The price should be quoted in the following format which should be inclusive of all charges. Taxes, if any, should be shown separately. However, GST will be paid to the successful vendor on prevailing rate at the time of billing / payment.

15. Payment will be made within 60 (sixty) days of submission of bill after successful supply & installation of the items after observing the requisite formalities.
16. Incomplete quotation not in conformity with the terms and conditions as in this quotation notice will be rejected outright.
17. The undersigned reserves the right either to accept or to reject any or all the quotations without assigning any reason thereof and is not bound to accept the lowest quotation.
18. Decision of the Technical Assessment Committee / Purchase Committee / any other committee constituted by the authority of Dr B Borooah Cancer Institute shall be final and binding in all cases.
